**Required for Men's Division 17+

Rules and Regulations

1. Each team MUST have four (4) players on their roster. Additions and/or changes on rosters will not be permitted.
 2. All games must start with three (3) players on each team. Any number (2 or 1) may complete a game.
 3. Each team is allowed one (1) one-minute and one (1) 20-second time-out. There is unlimited substitution permitted, but only when the ball is not in play, or after a made basket.
 4. In case of obvious injury only, a 30-second special time-out will be allowed for substitution of that player.
 5. Before games, both teams will warm up at the same time. The games will begin at five minutes past the hour or half-hour.
 6. A five-minute forfeit time will be strictly enforced.
 7. The Team Captain is expected to represent his or her team as spokesperson. All protests will be directed to the Tournament Director and staff. All decisions are final.
 8. Flagrant fouls or continued misconduct will result in dismissal from the tournament. A flagrant and/or deliberate foul will result in a free throw attempt by the team which was fouled; they will also retain possession of the basketball. The first time the Court Monitor calls a flagrant foul, a warning will be issued to that particular player and team. The second time there is a flagrant foul infraction, the player fouled will shoot one free throw and his team will then take the ball out of bounds. All free throws count as one point, just like a basket.
 9. Games will be to 16 points, win by one point, or 25 minute playing time. Two points will be awarded if a basket is made from beyond the 2 point line.
 10. The ball will change possession after scored baskets.
 11. Alternating possession on jump balls.
 12. Ball will be "taken back" on each change of possession. "Taking Back" means both feet behind the 2 point line.
 13. After "taking back" the ball must be checked by a defensive player before it is put into play. Offense must pass ball to a team mate to begin play.
 14. A coin flip before the start of the game will determine who gets the ball out of bounds first.
 15. A ball out-of-bounds will be taken out at "mid-court"
 16. All fouls will be played out-of-bounds at the back of the court (at "mid-court").
 17. No dunking is allowed in warm-ups or games. Players are subject to disqualification if caught dunking before, during, or after game.
 18. After a team reaches 7 fouls, the opposing team will shoot 1 free throw. If a player is fouled in the act of shooting and makes the basket, no free throw will be awarded and the team fouling will get the possession.
